## **Ongoing Business - Operations**

- A. Follow up from June's Meeting
  - 1. We discussed the inspection of the HS tennis court surface and will be monitoring the subbase movement on 1 of 5 courts while planning for the repair.
  - 2. We discussed the decommissioned equipment being stored on the maintenance grounds and are developing a plan to salvage that meets PDE requirements.
  - 3. We discussed two quotes to install irrigation to the lower practice football field. Extending the existing irrigation system was the most cost effective.
- B. Maintenance Vehicle Replacement
