  - April 11, 2022 minutes were accepted

#### III. OLD BUSINESS

- A. Policy 005.1 Board Committee Agenda and Minutes
- Committee discussed policy 005.1 and is recommending either retiring the policy or revising it to be much simpler; only indicating what is required by Sunshine Act. It will be pulled from a 2<sup>nd</sup> reading at the upcoming board meeting and either recommended for retiring or brought back to the June committee meeting for further discussion.
  - B. Policy 146.1 Trauma-Informed Approach
  - 1. Reviewed and recommended by the committee in October 2021.
  - 2. Ready for a first reading in May with June approval.
- Committee recommended we delay bringing Policy 146.1 forward for a first reading. The policy will be brought back in June for further discussion. The committee desires a more concise version rather than in its current form.

# VII. NEW BUSINESS

- A. Policy 810 Transportation
  - i. Policy update and practice
- Committee discussed Policy 810, accepted the suggested additions, and made minor edits. Policy will be sent to the solicitor for final review and barring any substantive changes, will be brought forward for a first reading in June. Committee also supports the Administration's recommendation to establish consistent guidelines for relaxing the transportation exceptions.
  - B. Policy 101 Philosophy of Education
    - i. Addition of updated mission and vision

- Committee discussed Policy 101 with revisions suggested and agreed that it should be updated when the district's new mission and vision statements are approved. Policy will be brought back to the committee in June.
  - C. Policy 105 Curriculum Development
- Policy 105 was discussed and the question of how we define "standards" was raised. Committee supported looking more deeply at Policies 105 and 102 to reduce confusion. Policies will come back to the committee in June.
  - D. Policy 120 Human Development
- Committee reviewed Policy 120 and recommends that it be retired. Policy will be up for retirement at the May board meeting.
  - E. Policy 123 Interscholastic Athletics
- Policy 123 was not discussed due to time. It will be brought back to the committee in June.
  - F. Next steps
    - i. Remaining Policy List for Review
- A discussion regarding next steps was tabled until June.
