## RESOLUTION 2015-05

## resolution urging the general assembly to establish a new FUNDING FORMULA FOR BASIC EDUCATION


#### Abstract

WHEREAS, Pennsylvania's more than 1.8 million public school students deserve the highest quality education; and


WHEREAS, the state's contribution in funding public education as a percentage of basic instructional expenses has declined from over $50 \%$ during the mid 1970's, to less than $35 \%$ today; and, on average, other states contribute $44 \%$ of total education funding, with Pennsylvania ranking 42 among the 50 states in the amount of state subsidies allocated to support elementary and secondary education and ranks $8^{\text {th }}$ in reliance on local taxes; and

WHEREAS, as the state's share of K-12 education funding decreases while the number of state and federal mandates for public schools steadily increases each year, additional burden is placed on local taxpayers to make up the difference to ensure that our students' education is not jeopardized; and

WHEREAS, in recent years, basic education funding has been distributed without the benefit of a funding formula, with the lack of a reliable, fair and transparent funding formula resulting in great disparities in how state education funds are distributed to school districts; and

WHEREAS, these inequities effectively harm the ability of school districts to adequately and fairly provide the resources for the different needs of their students, especially those in poverty, those with disabilities, English language learners and other students; and

WHEREAS, the Spring-Ford Area School District supports the development of a system of public school financing that addresses the needs of school districts and students, and establishes a school funding formula that is equitable, adequate, comprehensive and consistent.

NOW, THEREFORE, BE IT RESOLVED that the Spring-Ford Area School District urges the General Assembly to reinvest its interest in the support of public schools by taking legislative action to establish a formula that is predictable and addresses adequacy and equity for all school districts; and

BE IT FURTHER RESOLVED that the Spring-Ford Area School District will encourage others, including parents, students and district taxpayers, to contact the Pennsylvania General Assembly to convey the importance of establishing a fair and equitable public school funding formula; and

BE IT FURTHER RESOLVED that a copy of this resolution submitted to the elected senators and representatives of the Spring-Ford Area School District in the General Assembly, and to the Governor of Pennsylvania.

First on the agenda ... Review of SNAP finances:
As per the request made by the board to the Community Relations Committee at the January $28^{\text {th }}$ Work Session (part of the board agenda package) relating to Mr.Ciresi's suggestion that the board give $\$ 10,000$ to SNAP to help support the issues created by a budget shortfall, the Committee met with SNAP representatives to discuss their financial situation.

Spring-Ford SNAP: Students Need an Alternate Party (SNAP) is a group of Spring-Ford Area School District parents and community members working with the Spring Ford Education Foundation in an effort to provide a spectacular FREE post-prom event for all Spring-Ford Area High School juniors and seniors, whether they attend the prom or not. The annual post-prom party provides a safe post-prom alternative, focusing on the safety of SFASD students and the Spring-Ford community.

Prom night is statistically one of the most dangerous nights of the year for high school students. SNAP is committed to keeping the Spring-Ford community safe and free from drug and alcohol-related tragedy.

This year's SNAP Party - Into the Unreal:Where Fantasy becomes Reality will be held Saturday April $25^{\text {th }}, 2015$ 11PM to 4 AM

## The Remaining Fund Raising Events for this year:

Family Magic Show - February 28, 2015
Dodgeball - March 6, 2015 - Celebrating the 5 D's in dodgeball: dodge, duck, dip, dive and donate
Dancing with the Stars - March $28^{\text {th }}, 2015$
Color Run - May 17, 2015
I opened the meeting by asking the SNAP representatives to bring us up to speed with their financial situation. They expressed their sincere concerns about the $\$ 10,000$ shortfall and the consequences of not having enough money and not having enough volunteers to hold this year's SNAP post prom party event. They informed us of the fact that the SNAP post prom party being held this year is being financed by the revenues generated from last years fund drive while revenues are being generated this year for next year's event. They spelled out that not holding the Dancing with the Stars event last year significantly contributed to this year's budget shortfall.

I expressed my concerns about the school district setting a precedent by subsidizing a community funded event, considering that there are many other community funded groups competing for donated dollars and volunteer time and effort.

This cued a standing Mr. DiBello to passionately proselytize that SNAP, like so many Spring-ford programs, is dying on the vine, and if not subsidized by the Spring-ford School District ... if refused a well deserved $\$ 10,000.00$ financial infusion ... SNAP will not be able to continue to provide a spectacular FREE post-prom event. As the deliberation was morphing into debate, a voice in the crowd cried, "You are exaggerating!" which offered some comic relief and served to bring the debate back to deliberation.

Keeping in mind Dana Ludgate's words of wisdom: The success of the last event is an influential determinant for the success of the current event ... Conversation ensued with multiple suggestions for resolution including but not limited to:

- Spring-ford School District subsidizing the event
- Spring-ford School District loaning SNAP funds to get them through this hardship
- Using funds raised this year for next years event to fund this year's event
- Charging admission to the event.
- Making the post prom event part of the prom and combining efforts to raise funds
- Asking for a specific amount on the SNAP website
- Creating and implementing additional fund raising means and methods

The SNAP review took up most of the allotted 1 hour meeting time.
Financial and historical information has been provided to the board for consideration to determine the possible, plausible, probable and/or proven solutions to SNAP's financial predicament.

Second on the agenda ... Update/rewrite Resolution 2015-05 - Outlining Upcoming Town Hall event. With the limited time we had, we discussed concerns brought up during January $20^{\text {th }}$ Work Session with Item J: Resolution 2015-05 (part of the board agenda package). We recommend submitting the Resolution as is and making plans to invite State Representatives to an upcoming board meeting.

## Third on the agenda ... Community Engagement Consultant Update

With the limited time we had, Community Engagement Consultant Erin Crew submitted a document highlighting Press Releases/Media Coverage, Upcoming Projects, Social Media Updates. That being said, I'd like to take this opportunity to thank Erin Crew for what she brings to Spring-ford Community engagement efforts.

## Fifth on the agenda ... RCTV Update

Having run out of time, Steve Bonetz graciously offered to give me a tour of the RCTV Studio. I took him up on his offer and was very impressed with the experience.

Mr. Ciresi commented that a couple of weeks ago he had a conversation with the SNAP Committee which is going into its $9^{\text {th }}$ year. He stated that SNAP is an extremely important program and last year they were not able to raise the same amount of money that they had raised in years past. He stated that this is causing a budgetary issue for SNAP. Mr. Ciresi asked the Board to give $\$ 10,000$ towards SNAP to help support the issue this year so that it does not fall flat and the tradition that we have had can continue.

Mr. Jackson asked how the \$10,000 amount was determined and Mr. Ciresi replied that he and Mr. DiBello asked them and they indicated that this was the approximate shortfall from the year before.

Mr. Dehnert stated that if they were $\$ 10,000$ short last year it implies that someone had given money out of their pocket and this would indicate we were giving someone that money back. He added that he feels this creates some issues as we would need receipts in order to issue funds.

Mr. Ciresi explained this saying that last year SNAP did not host Dancing with the Stars which normally raises a lot of funds. He stated that the Committee put on the same program as in previous years which has them running at a shortfall for this year so they may not be able to put on the same type of event this year.

Mr. Dehnert asked if the Community Relations Committee could look at this in conjunction with the Business Office.

Mr. Cromley asked if this should fall under extra-curricular. Dr. Roche replied that it is not an extra-curricular as it is a parent run organization and the funds and books are kept through the Educational Foundation. Mr. Dehnert asked if it would fall under community relations and Dr. Roche stated he did not believe it fell under any committee as it is a parent run non-profit organization which supports the SNAP event.

Mr. Dehnert stated that rather than throw a motion out there he would like to see one of the Board Committees take a look at this along with the Business Office and then come back with a recommendation based on a little more in-depth investigation as to what is needed.

Mr. Anspach suggested possibly asking the Educational Foundation to make a donation as a donation was made in the past.

Mr. Dehnert asked what committee this should be taken to. Dr. Roche suggested possibly this was a Finance Committee conversation and they could look at the receipts and information that is there.

Mr. Ciresi stated that possibly the SNAP leaders could meet with administration and explain where they feel the shortfalls are and how much money it is. He stressed the urgency to act on this quickly as the event is in May.

Mr. Dehnert asked if Mr. Wolf would look into this at the next Community Relations Committee meeting. Mr. Wolf replied that he is willing to discuss this.

## I. PRESENTATION

Mr. Nugent, on behalf of the Board of School Directors, introduced the students being recognized and their parents. He presented each student with a certificate honoring them for their academic accomplishment.
A. Recognition of Samuel L. Freedlander and Alexandria N. Symonds for being named as finalists in the 2006 National Merit Scholarship Program.

Mr. McDaniel, on behalf of the Board of School Directors, introduced and recognized the Spring-Ford High School Girls' Basketball Team and Coaches on their achievement this year in winning the Pioneer Conference Championship. He presented the team with Resolution \#2006-03 commemorating their achievements. Mr. McDaniel also had the parents of these athletes stand so they could be recognized as well for their support.
B. Presentation of Resolution \#2006-03 to the Spring-Ford High School Girls' Basketball Team commending them for winning the Pioneer Athletic Conference Championship with a league record of 14 wins and 4 losses.

Debbie Landis and Cindy Clark gave a presentation on behalf of SNAP (Students Need an Alternate Party). This group is working to provide Spring-Ford High School with its' first ever post prom party; an alcohol free, drug free alternative. Mrs. Landis explained that an event of this magnitude requires significant amount
of funding as well as manpower. The SNAP Committee has set a budget of $\$ 25,000-\$ 30,000$ and as of now they have raised $\$ 10,000$. Mrs. Landis commented that they are hoping to receive some type of corporate sponsorship but as of now this has not happened. Parents are being asked to donate money and prizes in order to make this event successful. Information is posted on the high school website. Mrs. Landis thanked Dr. Hurda, Pat Nugent and Bill Shirk for their support. Dr. Hurda recognized Mrs. Landis, Mrs. Clark and the SNAP Committee for their hard work in getting this initial event up and running.
C. Post Prom Party Presentation (SNAP) by Debbie Landis and Cindy Clark.

Due to the absence of Mr. Morgan, Mr. Ciresi gave an overview of the "House of Heroes" Project that the Western Center for Technical Studies is undertaking in an effort to contribute to the area devastated by Hurricane Katrina. Mr. Ciresi said the home would be built here and then transported down to Louisiana via a barge. The United States Army will be setting up a tent city so that the students involved in this project can be on location when the house arrives and assemble it. Mr. Ciresi said the biggest issue for this project is the funding as public tax dollars cannot be used. The estimated cost for this project is $\$ 200,000$ and donations from our community and surrounding communities is being sought. Mr. Ciresi said additional information is available on the Western Center's website.

## D. Presentation on the WCTS "House of Heroes" Project by Ammon Morgan, Jr.

Dr. Hurda gave a brief overview of how the name was chosen for the new elementary school. The proposed name is Evans Elementary School after the Evans Family, the second family to settle in Limerick. Dr. Hurda gave us the history of the Evans Family and how they settled in Limerick.

Rick Schroeder, Spring City, asked about Item M under Finance which is the resolution to place money into the Capital Reserve, he wondered if it would not be better to delay this until the preliminary budget has been set. Mr. Schroeder asked about Item K under Personnel and questioned whether it would be better to reword the job posting to just say assistant track coach and not have the emphasis on pole vaulting since there are only a few athletes who actually pole vault. Mr. Schroeder wondered if the support on the "House of Heroes" Project was $100 \%$ from the Joint Operating Committee because he has gotten some feedback from members of the Western Center staff who feel they were forced into this and that there may be local people who are in dire need and could benefit from a project like this. Mrs. Williams suggested Mr. Schroeder address this at the next Joint Operating Committee meeting.

## VII. FINANCE

Mr. Dehnert stated that he looked at the resolution for Item J and he does not feel that it is totally suited for Spring-Ford as it talks about a fair equitable formula for funding. Mr. Dehnert stated that he is not sure what this means but he believes that since SpringFord has a good tax base therefore Spring-Ford to be fair would not get as much tax money from the state as other districts would. Mr. Dehnert commented that he is not really in favor of leaving those words in the resolution. Mr. Dehnert added that he feels our fight is that we want the state to fund mandates and provide us with adequate funding.

Mr. Pettit stated that the resolution looks like a fairly innocuous one that the legislators will ignore in any event.

Mrs. Heine commented that she is not in favor of changing the wording to the resolution as this is something that has been used as a platform for getting votes and the funding formula has been discussed many times and needs to change.

Mr. Dehnert again stated that his objection is to the wording "equitable funding". He added the district's funding from the state continues to go down.

Mr. DiBello commented that the reason our funding is going down is because the other district's percentages are going up. The taxes we are collecting are being used against Spring-Ford and that is why we are getting less funding and not equitable funding. Mr. DiBello stated that the whole movement is to have a funding formula in place that is fair across the state for all 499 school districts. Mr. DiBello added that there are some school districts where most of their funding comes from the state whereas Spring-Ford only receives about $21 \%$ of their funding from the state.

Dr. Goodin stated that he has been involved with this discussion at the MCIU along with the other Montgomery County Superintendents. Dr. Goodin reported that the Funding Commission is being charged and challenged to look at all 500 districts across the state and provide fair, adequate equal and sustainable funding.

Mr. Pettit stated that he thinks the resolution is fine as it is written.
Mr. Dehnert questioned the need to do a resolution since some board members indicated they did not feel the legislators read or act on them. Mrs. Heine replied that she believes the goal is to have many districts act on this and everyone send the same resolution in hopes that there would be strength in numbers.

Mr. Dehnert asked if this is the first time we had done a resolution such as this and Mrs. Fern replied that the Board had passed the same resolution this time last year. Mr . DiBello stated that there is a state-wide initiative looking into this now so hopefully something good will come about this time around.
A. Administration recommends approval for next month's payroll, taxes, all benefits, transportation contracts, IU contracts, Vo-Tech payments, debt service payments, utility bills, maintenance agreements, copier leases, equipment maintenance, Federal grants, insurance, and discounted invoices.

## RESOLUTION 2015-05

## resolution urging the general assembly to establish a new FUNDING FORMULA FOR BASIC EDUCATION


#### Abstract

WHEREAS, Pennsylvania's more than 1.8 million public school students deserve the highest quality education; and


WHEREAS, the state's contribution in funding public education as a percentage of basic instructional expenses has declined from over $50 \%$ during the mid 1970's, to less than $35 \%$ today; and, on average, other states contribute $44 \%$ of total education funding, with Pennsylvania ranking 42 among the 50 states in the amount of state subsidies allocated to support elementary and secondary education and ranks $8^{\text {th }}$ in reliance on local taxes; and

WHEREAS, as the state's share of K-12 education funding decreases while the number of state and federal mandates for public schools steadily increases each year, additional burden is placed on local taxpayers to make up the difference to ensure that our students' education is not jeopardized; and

WHEREAS, in recent years, basic education funding has been distributed without the benefit of a funding formula, with the lack of a reliable, fair and transparent funding formula resulting in great disparities in how state education funds are distributed to school districts; and

WHEREAS, these inequities effectively harm the ability of school districts to adequately and fairly provide the resources for the different needs of their students, especially those in poverty, those with disabilities, English language learners and other students; and

WHEREAS, the Spring-Ford Area School District supports the development of a system of public school financing that addresses the needs of school districts and students, and establishes a school funding formula that is equitable, adequate, comprehensive and consistent.

NOW, THEREFORE, BE IT RESOLVED that the Spring-Ford Area School District urges the General Assembly to reinvest its interest in the support of public schools by taking legislative action to establish a formula that is predictable and addresses adequacy and equity for all school districts; and

BE IT FURTHER RESOLVED that the Spring-Ford Area School District will encourage others, including parents, students and district taxpayers, to contact the Pennsylvania General Assembly to convey the importance of establishing a fair and equitable public school funding formula; and

BE IT FURTHER RESOLVED that a copy of this resolution submitted to the elected senators and representatives of the Spring-Ford Area School District in the General Assembly, and to the Governor of Pennsylvania.
