 - 1. Policy # 246 Student Wellness District Wellness Committee is in the process of reviewing our current policy due to changes to Student Wellness expectations from PDE Dr. Patschke and Mrs. Germinario visited the meeting to share some suggested edits to Policy 246 based upon recommendations from the District Wellness Committee and as a result of changes from PDE related to School Nutrition Services. Additional work is needed on the suggested changes and the administration will bring those changes/updates to the November Committee meeting.
 - 2. Policy # 204 Student Attendance Updates needed based upon changes from PDE Committee reviewed the revised policy based upon changes made by PDE and state laws regarding school attendance, truancy, school attendance improvement plans and petitions to court for students who are considered habitually truant.  - 3. Policy # 484 Sick Leave Update needed due to change in Professional Agreement Committee reviewed the revised policy that needed to be updated based upon new language in the teachers' contract regarding sick leave and unused sick time. The updated policy is on the agenda for a first reading.

Since the committee meeting, the attorney has provided the administration with a newer interruption of the policy change that includes a revision to Policy 103 and adding a new policy (104) to the book of policies. Additional conversations will take place on both Policy 103 & 104 at the November committee meeting.
